	SUMMARY

The Board of Commissioners held a public hearing on August 19, 2019 and thereafter approved moving forward with an economic development project to be named at a later date. As a part of this project, the County intends to acquire ninety-eight point twenty-four (98.24) acres of real property located on Colon Road (PIN 9655-21-2728-00) currently owned by Richard and Angela Hearn at an estimated purchase price of one million one hundred and thirteen thousand six hundred and sixty-seven dollars (\$1,113,667.00). The County will convey approximately seventy-eight (78) acres of property to the company associated with the economic development project and retain the remaining property to be developed and sold as a future industrial site. The County intends to use funds from the County's General Fund and funds financed through a borrowing with a financial institution to purchase the property.

To access the site, the County intends to purchase a strip of property sixty foot (60') wide by approximately nine hundred and eight-five foot (985') long, plus or minus, along the southern border of property located on Colon Road (PIN 9655-30-3668-00) and currently owned by Jimmy and Carol Poindexter. The County intends to use funds from the County's General Fund to purchase the property.
